

Hello,

I have a case in the Norwegian system I want to share with the world. The case is about Norwegian institutions lie and plant evidence to protect the mother of the kids. I sit on information that can prove judicial murder on me two times, two child psychologist statements that are 100% nonsense and corrupt, child service that have written reports that is not connected to any documentation at all, two Norwegian schools in Spain that have reported me to Spanish child service on behalf on the mothers words which she said openly was her doing in court, child service that has refused to take my evidence, court refused to take my evidence, police refused to take my evidence, I was basically locked out of the system, and with this they made a character assassin against my two oldest kids that are boys and myself. My boys at that time was 9 and 12 and was written into the report from child psychologist that they are in the zone of having a "mental illness" in the future. There will be documents available from both sides which means, child service, Norwegian schools, Norwegian Court, Norwegian Police, mother of the kids are on one side, and then there is me the father of my three kids. It is the mother of the kids that are the main character of making everything go corrupt.

My main goal with going to the media is that I want everyone to see both sides of the story. It will not be able to hide from the documents written or said from anyone from either side. Right now, the Norwegian court has put down a law that I cannot make the final document from the case public, just so they can hide from their corruption. I have reached out in four different mails to court this year so they can send over the court decision against me, and they refuse to give it to me. By law the court decision against me is not allowed to be withhold against me, but court don't care and think they will come away with it. I can prove it all. I have enough documentation so everyone can see that there is no way the case has gone the way it should have gone. Court makes their decision mostly by a second part that is a child psychologist. And this report is available. This psychologist is put into the case as a "neutral" part. But again, I can prove that his whole report is total corruption. This report is enough for everyone to understand that the case is 100% corrupt. 2 judges, 2 child service psychologists for two different court meetings, 1 regular child service employee and 1 child service leader has everyone delivered reports that I can easily prove wrong. But no one cares. I want my kids. And I want to take

down this system. Government was highlighted by this case earlier this year 2025 and nothing has happened. Then I guess everything is in my hands because everyone does nothing to give me my kids. I have been patient enough.

If someone wants to cover my case with having interviews etc that is a possibility, but that is not free. And this will not be a cheap session; I need to raise money for my kid's future. I am also searching for donations.

I will now go into the case in general so you can be highlighted with facts and what is documented from my side, and this starts januar 2019. The problems started of course before this, but that is when I got the first picture of my daughter in a really bad condition:

## Start of January 2019

My oldest child, Leon, was categorized as an ADHD child and dyslexic by the Norwegian school system and my ex for the first four years of school. I, on the other hand, thought there were other reasons for his reactions. His reactions were extreme with tantrums almost every day and they lasted up to 45 minutes at a time, until he got tired. This meant swearing, hitting, throwing everything he could find, etc. I think you get the point. My problem was that he had no challenges before he started school. In kindergarten, he was praised by everyone, even in other departments who said he helped everyone who needed help regardless of age. Extremely playful and happy. When his school with the principal, PPT, special teachers, dyslexia teachers, my ex, etc. had meetings, they tried to convince me for 3 years from second to fourth grade that I had to sign a document for further evaluation in order for him to get the diagnoses and the help he needed. I refused.

When the third grade came, the relationship between me and my ex ended (2018), and with this I had the children about 60-70% of the time. This was because my ex had an agenda that was not about the children, but about coming after me. So I had to protect the children as much as possible. This time lasted from January 2019 to May 2020. During this time I had the opportunity to find out what my eldest son's problem was. When you look at the story in its entirety, you finally understand that the ex is the main reason for the problems outside of reactions, but there is more behind this

than just the ex. When I picked up the children and had them alone for 2 months in the summer of 2019, I saw after just one week that my children could be completely calm under the right circumstances. What I found out was that my children reacted to different things in the house and what clothes they were wearing, and so on, there is more. This problem meant that my children had been sitting in things they couldn't stand day in and day out, and then it goes without saying that it is not possible to sit still. This is an extremely tiring affair over time because I struggle with the same challenges. And it is something that affects us slowly over time so it is harder to find out specifically what it is we are reacting to if you don't understand everything. I told my ex what she had to do to keep the children calm but she refused to listen because she had another agenda.

My ex's agenda has been to come after me all along, to have me portrayed as a man I am not and here it starts to get complicated about what I could prove at that time, and what I could talk about. At this time I took pictures of the children and documented that my children had various rashes on the body. The ex said it was hives, fifth child disease, eczema, etc. anything that could cause red, large or small rashes. Her problem is that the children were only red with her. So every time I picked them up they were red, and after a day with me with the right clothes and the right handling of the house, their skin was completely fine everywhere and calmer right away.

The reason the ex wouldn't tell the truth is because she has told everyone that I am "mentally ill". So how was she going to manage to hide the truth behind her agenda? She used the children. I react to a number of different things in everyday life such as clothes, chlorine, strong smells, bad air conditioning, different animals, latex, the list could go on, but you get the picture. My problem was that I could never tell anyone what was wrong with me because my mother had already been categorized by this system as "mentally ill", if I said that I had any kind of reaction it would have been categorized right away. I have seen my mother lying almost to death, completely paralyzed from her toes all the way up to her head, given intravenous, after a month eating with a straw because all her muscles were out of order. Full of chemotherapy without any "psychic" drugs for over 4 months without her having a single "psychic" reaction. So this was enough evidence for me that what happened to my mother was not true either. But, that is another matter to be discussed. Had to explain so that people understand how they used my mother to take me. So I have simply

been muzzled since I was 16-17 years old about this until I was 35. When you see the first picture on my daughter's website, this was my time to start opening my mouth because now I have proof that my children react to things, and then you can no longer say that if I feel the same as the children then I am "mentally ill" because then my children are the same. Now I had found a way to break down what I was in. But, first I had to prove that Leon did not have ADHD and dyslexia.

With this, I made a plan to take the children 100% for a year, the plan was first in the west of Norway, we are from Oslo, which the ex accepted since she had started a business and I had the children up to 70% anyway. This was during the time from when we broke up in 2019-May 2020. I picked up the children in May 2020 and I felt confident after a month with the kids that I could easily prove that Leon did not have ADHD, and if I had gotten him calm I would be able to teach him school. But here I had a problem and that was that when I proved that Leon did not have ADHD or Dyslexia, what happens then? I was too close to the ex because she does not want me to prove that everything is just made up on her part and the school in Norway for the first 4 years. She would have easily flown over to Bergen or wherever we had ended up and made hell. So I managed to convince my ex that I would take the kids to Gran Canaria 100% for a year. This was something I managed to push through because Covid broke out this year and there were the fewest cases of Covid in Gran Canaria of all places at that time. So my ex confirmed this. (You can draw a conclusion here whether I am "mentally ill" or not. If my ex goes around saying I am "mentally ill", how could she accept sending me to Gran Canaria alone with 3 children, 4-7 and 10 years old for one year? This alone speaks volumes about this topic. You can also include the fact that it was a pandemic and all airports were closed and complete chaos. So there are many factors that say that what she says is not true. We got out due to a opening of a week or two in the airport. The court decided to say that the Ex "found out" that I was "mentally ill" after I went to Gran Canaria, but I am completely guarded against this with repeated recordings of the Ex from Gran Canaria about how the situation was in Norway before I left. So the court is lying about the course of action in order for the Ex to get away with why she sent me alone with my children. The Ex says I am "mentally ill" because I say the children react to different things. When you then take a look at the website you can easily understand that this has been a long-term problem. But, as I said, the

court, child expert, child welfare all deviated from the truth and made up their own stories that can be easily broken down.)

I had the children alone from May 2020 until the end of August in Norway before we ended up in Gran Canaria, and the children started school after a month. My daughter had to wait a couple of weeks since all kindergartens were closed, so she had to go to preschool in the Spanish system. When Leon started school (my oldest son), I told the teacher that they must give me 4 months without homework on Leon, but treat Leon like a normal student in class so that he does not feel frozen out in class. I knew that I could prove after a month at this school that he did not have ADHD, because he was now with me completely calm without swearing, without screaming, without hitting, he was a normal boy with control over himself. After a month at school, they confirmed that there is not a shred of ADHD in Leon and this is now a problem gone. So my next problem was to solve dyslexia. I asked them to take a mapping test on Leon when he started school, the test showed that he was at the end of the first grade level. He started in the fifth grade. And then you can understand how far behind and what kind of hell it was at school back home in Norway. I asked for about 4 months without homework, said verbatim that the Norwegian system has tried to help Leon for 4 years without success, now it is my turn. This test was taken around the end of October if I remember correctly. He couldn't read words, he spelled the letters in order so that it became a stop throughout the word. The only thing I asked for from school was a writing book from first or second grade. I think most people remember this one, where you trace all the letters with a pencil, etc. This was important to me since Leon knew the alphabet, but the letters he wrote were 80% uppercase and he didn't know what the lowercase letters looked like or where they belonged. And I can repeat that he started in fifth grade. So I did school work with Leon every day after school and on weekends to see how fast he could develop. I invented my own ways to maximize his development. Took everything step by step and was never allowed to rush. To make this story short, they took another test after Christmas, 3 months after I started my process with Leon. Leon had increased from being at the end of first grade to third grade in 3 months. I had made Leon increase two semesters in 3 months. I had proven that everything that happened in Norway during the first 4 years of school was completely out of control and nonsense, something I could prove in 3 months, no one with dyslexia could

have done this. Now in retrospect the ex says that she never said that Leon has ADHD, but I have a doctor's note from Leon's doctor that she went to the Leon`s doctor behind my back and said that Leon and I had ADHD 4 months before I took the children 100% and travelled to Gran canaria. I don't have ADHD. Well, maybe, if you really want to, everyone has ADHD to some degree. The ex tried to go around the school system to get Leon diagnosed since I didn't sign off on Leon getting a more thorough assessment and diagnosis in the school system. But this has nothing to do since I am 50% responsible for the children and then both must approve and sign regardless of where you want to get these diagnoses. This doctor's visit allows you to catch the ex in a blatant lie to cover up her own actions and agendas. (For my ex, it was extremely important to make Leon have ADHD to cover up the fact that there was no “allergy or different reactions to things” that made him out of control. That way, she could continue to say that I was “mentally ill” and use this for all it was worth. That’s why Gran Canaria was an important post for me and the children. )

Once I had proven that Leon did not have ADHD or dyslexia, my next challenges started on a continuous basis. The school nurse at Leon’s school in Gran Canaria came to me right after Leon turned out to be two semesters ahead and told me that Leon needed extra tuition at school after the coming summer. Because at that time, the plan was that I would have the children in Gran Canaria for two years, or until that time. The reason for two years was because my daughter Nova had started preschool in Spain and had learned Spanish, started learning letters, numbers, reading, writing, etc. So why take her out of school and into Norwegian kindergarten for a year? This doesn't make sense. (Ultimately, Nova could write her name and the names of other students without reading the letters first, she could understand what the alphabet was, she could read different words "in Spanish, of course", counted to 30 in Spanish, English and Norwegian, she spoke Spanish fluently. Nova was 4.5 years old at this time. She spent 6 months on this. And then you can understand how my children can develop under the right circumstances. The story of Nova today is that she was kidnapped by my ex in the summer of 2021, a year in kindergarten, and fell back into the Norwegian school system the first year of school. So Nova can't handle Norwegian school, which is her native language, but with me she had an extreme development even though it was a foreign language included and a completely new environment. What I am writing here now is

something that experts, child welfare and the court refused to go into. They refused to get any information from Spain because they knew what I had done and how well my children were doing.)

In short, I told the nurse, no, I'll fix Leon from now on until he's 100%, and with those results I could have fixed Leon in a short time. I didn't understand their agenda right away, but in hindsight I did. I said no because I felt like a better person to develop my son, which I can prove. What their plan was that if I stayed another year and Leon had then gotten a remedial teacher, they would have taken full credit for all the development and submitted why and how I fixed Leon. Thus, the ex would have managed to hide what is the reason why Leon had the problems he had in the first four years at school and how I fixed this. (Today, my second son Gabriel is in exactly the same situation as Leon was in the first four years, and has been like this since the ex kidnapped my two youngest children from Gran Canaria in the summer of 2021. So in hindsight, this was an extremely important decision to say no to). 1 and a half months later after I said no I received a child welfare case from this Norwegian school, where they had specifically gone after my other son Gabriel to make a case against me. This entire report is created on behalf of my ex. (She openly said in court "I made the schools make child welfare cases against you". Something that was not taken into account in the main proceedings.)

When the child welfare case came I had to deal with the Spanish child welfare who could not fully understand the situation, because things did not match the reports from the school and what I have of information and documentation from the first 4 years. It ended with a meeting that you can hear on the website. Now a lot happened between the child welfare case came up and this meeting happened, but I'll skip ahead to the most important elements. In the meeting it was acknowledged that I had to submit a report on my children's reactions to things, because it's "clearly" not enough to have photo evidence and video of the children. This was something I fixed and submitted within these two days that were agreed upon in the meeting. During these two days, the ex got the two youngest children since the child welfare said I had to let the ex see the children. Leon wanted to see friends first and had a cast on his foot. During these first days you can see various video calls, photos, recordings of the ex about what happened when she took the children. The whole situation was turned upside down for the two youngest, and the ex ran a manipulative

battle against the two youngest that they were not allowed to tell how they felt at her place, which a video recording with Gabriel shows in Gran Canaria, and repeated recordings from their time with the ex in Norway, as well as messages from the schools in Norway to my two youngest that they do not talk about their feelings. (Something the court and expert refused to include in the reports). Since I received some evidence in the first days after my ex took my two youngest and I had enough conversation recordings that showed how the situation was at home in Norway before I left with the children, I decided to report my ex in Gran Canaria in the Spanish system, I started a legal case against her. And since I had the passports, she had to go to the police to be able to pick up these passports, but since there is a report lying around, they said no. And then my ex had a problem, because the child welfare service also refused to help her out of the situation. At this time, the child welfare service in Spain had received a conversation log between me and my ex where they could read how she tells me lies about what the child welfare service in Spain means by one thing and the other. And is threatening in her speech. (This can be read on the website). What her problem is that the child welfare service has never issued any concern about me, they only passed on the information from the Norwegian school to me and the ex. The child welfare service has not made any decision. Thus, this did not strengthen the case of the ex. Because it's easy to see the lies. Since she didn't get the passports, she had to find a way out with my two youngest, she went to the airport with both of them and cried her way out of the airport with the children. I asked my middle one how they got out, and what he said was that his ex told him not to tell anyone, but what happened now was not legal. (Gabriel still had trust in me as a father, which you can also hear from the recordings I have with him after he had been kidnapped for 2 years in this country, but it's a struggle for me to get him to open up. My ex kidnapped the children and I still have all our passports here to this day. She has told her family and mine that she had the passports for the one or the two youngest, she didn't tell child welfare and other institution this directly but also did not say that she left illegally. Only in the main proceedings in December 2023 did she say outright that she took the children out illegally in 2021. But, who cares about kidnapping children in Norway? The kidnapping took place in the summer of 2021.)

Gotta jump on from this. Now we are in the same year, Leon and I are going to Alicante after a meeting with my lawyer, (conversation can be found on



the website), where unfortunately we still had to go to Norwegian school because Leon is too far behind in the school system and then I do not want to push him in a foreign language environment, that would have been crazy. So then we ended up in another Norwegian school, and it was not good under any circumstances. After a month Leon started to be bullied by 3-4 classmates on a daily basis. After 2 months, another child welfare report came which is again 100% dictated which I also have a recording of. (Can be heard on the website, this is because we had a meeting on this topic. Then you can easily hear that everything is crazy). Furthermore, the bullying ended up going from psychological to physical. A big fight where the two strongest in the class took Leon, one of them held Leon's arms behind his back while the other hit him in the face. When Leon is released, one of them grabs Leon's head and slams his head into the brick wall twice. Leon's words "I lost all feeling in my body, I was on my knees and couldn't move". This school writes in every episode that Leon can thank himself. No need to go into detail here, but what they literally say is that Leon wakes up every day as an 11-year-old and goes to school and starts making hell with the "cool" and strongest guys in the class. With this, I took Leon out of school and ended up as a refugee from the Norwegian system. I wanted nothing to do with this again. (Everyone who reads this understands that there are very few children who have the attitude that they should attack 4 boys in the same gang every day. Again, the truth about what really happened and what a brutal everyday life my son had at this school is being hidden.)

After this fight, I took Leon with me at the end of March 2022 to find a new place with new opportunities, but now it was in a Spanish school, I only spoke English at home so that he could be more easily guided at school with an interpreter. After six months as a refugee from the Norwegian system, I tried to find a place to live, was hacked twice in 3 months and lost over 15,000 euro. This meant that I had no other choice but to take Leon back to Norway. Because I did not have the funds. When we came to Norway, my father submitted a report of concern to the Norwegian institution called (NAV, they deal with who gets money in this country) that I was not suitable as a father due to my mental health. (Now we come back to when I was 16-17 years old and the reason why I was muzzled until I was 35. This is the person who put me on the same level as my mother if I said anything). Back to now. My father only gave one example of why my son is

not doing well with me. "Leon helps out way too much, when my wife Hege asked if I (my father) could cook something for her, Leon jumped up and said he could help. And he did this on several occasions." This is the report of concern that has been submitted and is in writing in this case, so to speak verbatim. Hege has a lot of complications with her body. As a father, I expect my children to take care of the weakest and especially those closest to us. This is a given. My father wrote that Leon was too kind. I think this says something about what I have lived through as well. But, this is not about me. Nav forwarded this message to the child welfare service in Farsund, Lister child welfare. I knew that I had to have a conversation with the child welfare service regardless of this message to my father. From what I have been told, it is legally required that the child welfare service knows why a child starts school later than usual. This was fine to that extent. Now I do not know 100% if this is true. But that is what everyone told me.

Now I was standing in front of a child welfare service that was going to try to fight me down. I told them that I had gotten Leon from being "dyslexic" and "ADHD" to being a boy who respects everything that has to do with school, sits quietly and follows along, has very good development, etc. "extreme development" if you think about the circumstances Leon has been through. Here, several things have happened with the child welfare service, but take the most important thing. They refused to receive evidence from me. They manipulated the report from Farsund elementary school and did not include the last reading test on Leon which proved that I had done my job. The last reading test on Leon at Farsund primary school showed that Leon was only 7% off the norm. This was in seventh grade. So in two and a half years alone with me, only 7-8 months of school in Gran Canaria, only 4-5 months of school in Alicante, I had increased Leon by almost 6 semesters. So even though we have been on the run and whatever we ended up in the last 2,5 years we nailed it. Leon has had a life where he had to read and write almost every day to get to same level as in junior high school, also in vacations. When we started the process in Gran Canaria, I told Leon that we have plenty of time, but we have to reach the goal by junior high school because then grades will come, then it is important to have reading comprehension and written reliability to make everyday life easier. (And with this I can say that I helped Leon to crush all the results that you could imagine that he could achieve, at least considering the Norwegian school in

Norway before we left would send him to a special school for ADHD and disadvantaged children just outside Oslo 3 years before. All this documentation that is in favor of Leon's development has not been taken into account, the judge's words after the main proceedings are "Leon's test is not relevant to the big picture" This is stated in the decision and the decision taken against me as a father.)

The child welfare office in Lister decided that they should carry out the report and did not believe that I had any extra documentation. The first child expert (child psychologist) came into the picture. He writes that I am "mentally ill" because I say that I have documentation on a memory stick. (Now the website is up with all the documentation, and one can safely say that I did not lie about having documentation. But it was not enough that he wrote that I lied, this expert did a direct character assassination on me even though I had documentation. He portrayed me as "mentally ill" in the report, something he is not allowed to do as an expert in a child welfare case. The same with the next expert. So with this you understand how this report has again been manipulated to take me without any basis, it is only made up stories, and they have not checked whether what the ex says is correct, whether it matches the reality, etc. They have gone ahead. You can see everything on the website. There is much more to this, but you can also see that on the website. I can say that when I have sat and heard child welfare managers, child experts, judges, police, etc. lie and manipulate me right in the face from two meters away, it was a twofold feeling, one was that they were only giving me more wood for the fire against the madness, and the other was that they were stealing the time I should have had with my children. Because the only thing they have done up until today is to gain time.)

Child welfare refused to receive the documentation. I went to the district court to give them the documentation since the child welfare department refused. The district court refused to receive it and said that since it was on a memory stick, they couldn't accept it. Then I asked how are you going to see this? Because the child welfare department didn't want it either. They sent me on to the police. The police refused to let me come in to talk to them. I didn't even get an appointment to tell them what I had. I tried over the phone several times. Finally, I went there and got a hold of a guy outside the police station. I got to the counter 10 minutes before closing time and no one came to answer, so I waited outside until someone was on their way

home. I'm in a desperate situation and I have a recording of this conversation. He asked me to call one last time and not tell him what it was about, just ask for an hour. I tried this too, but nothing. I was simply completely locked out of the Norwegian system. The reason the police locked me out was based on the report to the child welfare service, (that's what they said). When the District Court a couple of weeks before this refused to accept documentation, I started the process of creating a website where I can communicate all the documentation of photos, videos, conversations, etc. I started to run out of time because I had to be able to deliver this by the spoonful by email before the case came up in the district court, I didn't want me to get in there and they continue with their course by saying, "we knew nothing." Therefore, I sent the website with all the documentation to the district court, the police, the Supreme Court, the Court of Appeal, child welfare and what went with it so that they could just forget to tell me that they didn't know. This meant that everyone who submitted reports that were corrupt must be responsible for what was submitted. Because everyone had 4 days to pull the emergency brake, but they chose to kidnap Leon instead the next day. (Everything I have talked about up to now was documented before the first court hearing and the kidnapping of Leon. And I didn't stop locally, this went out regionally. So everyone in Oslo and the surrounding area and Agder knows about this case and has known about the website I'm showing you since May 2023. From that day on, everyone who wrote and submitted reports against me with conscious actions has constantly had access to what they are reporting about. And that didn't stop the madness. And this is also a reason why I have to get all this information out. This whole country, if you go even higher up in the system, has known this since January 2025. I haven't gotten an email back from anyone who wants to help. Not a phone call. Only an attempt to save skin from Agder County Council. But that was it. And those conversations will come out on the website eventually. What an intolerable system we have with morons at the highest level, with the lowest IQ. This will be shown.)

The website was submitted 4 days before the first negotiations were set. The next day they kidnapped Leon based on reports that are 100% corrupt and do not follow any documentation whatsoever. There is no substance to any of the words used other than the names of me and the children and how old we are.

After this, an extremely difficult time followed because now not only has the ex kidnapped my children, but this system in Norway has also contributed to this. (Now it is the ex who pulls the plug here, but everyone is responsible for their own actions, and everyone will have the consequences that come with it. And there is no way for them to hide this.)

6 months later there are main proceedings, a new child expert comes in with a new judge. I know that I will face the same set-up in the end. (You can listen to the recording with the last child expert about how much he manipulates and lies in the conversation, goes against school documents that he is supposed to take part in and familiarize himself with, and says they do not exist while I sat and looked at them while I talked to him. You can also see this on the website. This report is pure madness and makes it so that my two oldest children, my two sons, Leon and Gabriel are "mentally ill" if the ex wants this. This is something that at the time was about two boys aged 9 and 12. It was not important to include Nova because she is not like the boys. Those boys do not forget what they have seen the ex do. They do not forget what they have been through, and they say what they feel is the greatest fear of the ex. Then it is better to keep their mouths shut. So if they say something the ex doesn't like, they are "mentally ill." The ex says every time Leon is upset in the house that he is "mentally ill" like his father in front of the youngest Gabriel and Nova, and what happens when the youngest argue or act in conflict with Leon? Then they say he is "mentally ill" so this is the home this system kidnapped Leon into. Today when I write this the date is 12.10-2025, they kidnapped Leon at the end of May 2023.)

What is also a big factor here is that in this report to the last expert is that he says ultimately that my children react to things, and the ex confirms that my children react to things. In this report it is stated that when Leon tells about what he has seen and experienced about reactions he is portrayed as a boy who "does not know what he has seen, has been manipulated by his father, etc." When I as a father say what I have seen and experienced about these reactions, I am categorized as "mentally ill and does not know the correct picture of reality". However, if the expert says this and the ex, then it is fine. This is the madness that is repeated in the report. Leon has only said what I have documentation for, nothing else. Same with me. This is how

this report to the expert is written. So when you go to the website it is important to read the expert report first and then my response.

I have tried in 4 different emails to get my decision and ruling on my case from the Lister District Court at the beginning of 2025. I do not get a response, they refuse to send me the ruling that is my personal property because this includes me and my life. Their decision on me is not theirs after it has been given to me. So the Lister District Court is going against its own laws again by withholding documentation about this case. Now it should be said that this is the document they set a law on that I cannot show. So the decision in case. So maybe it's for the best that I don't get this and don't show this. This is not a great necessity since the child expert report is over 70% of the decision made in a child welfare case, and the expert's report on the website is practically identical to the decision.

The reason I'm sending you an email is this:

As of the main court meeting in December 2023 and the decision in January 2024, I have not paid any form of tax or VAT to this country. I am the father of 3 children who have been kidnapped right and left without consequences and all levels of the Norwegian system have been 100% involved in this kidnapping. All systems in Norway know about this case from child welfare all the way up to the top. If I then pay anything to this country, it would mean that I am literally paying for the kidnapping of my own children. I think everyone who is a parent reaches a limit on what is acceptable and what to obey. I have followed the law up until now. Done all the cases according to what the system expects. Did everything in my power to fight this case alone, and slowly but surely get back on my feet again physically and mentally. But I will not pay for what this country has done to me and my children. It is not happening. On 9.10-2025 this country decided to go into my bank account and withdraw a sum of 75% of an invoice that was supposed to go to complete a project that within two months would have meant that I could finally get enough funds for a decent lawyer. It turns out that it is clearly not going to happen. And thus, I have to apply for donations to get out of this situation. Now I have said since the main court in 2023 that the day someone steps in and takes money I will launch this website and make it go viral. Now the time has come, I hoped I could earn enough money first and work my way to this, but that was not

the case. Now is the time for everyone to see what my children and I as a father have been through the last 7-8 years with a 100% corrupt system.

The report you read from the last expert Bent is almost identical to the decision given by the court about me.

The website you see below is a brutal and honest representation of what this country has done to me and my children. It represents everything that has been neglected in this case. Everything you see on this website is ultimately not taken into account. What is written above is only 10% of what has happened. There are many incidents in between here that will give more meat on the bone, but this is more than enough to have a full understanding of the case. The website you are now getting will start going viral now. There is no reason not to share the website or the story if you want this. You will also get a pretty brutal picture right in the face of my daughter. My daughter at this time is a little over 1 year old. But this is my reality. This picture is something that has been neglected from all sides to protect the ex. The child expert tries in a manipulative way to undermine the seriousness behind this picture. He first says that he thought it looked like I had hit my daughter and had to ask the family if this was true. And then he says, it looks like she is having a reaction. This is pure manipulation by a child psychologist who is supposed to be sitting and deciding the future of children in this country. He puts maximum pressure on violence against my daughter, and then gently talks about what is happening to my daughter. He thought maybe he was smart enough to get away with it, but that doesn't happen. All normal people would get a punch in the face from the picture of my daughter, and understand that this is not violence, but a major reaction. But, it is a picture that basically did not exist before I launched this website. Leon's friends back home in Norway told me and had discussions with me that my children have no reactions. So who told Leon's friends this? Now it should be said that they talked, and I said nothing. And they still don't know anything until now. Now this website is being launched, and everyone will know what these people have done to my children's and my life for the past almost 8 years.
